



**LIMITED 20 YEAR BAHAMA SHUTTER WARRANTY**

The manufacturer of Bahama shutters, Affordable Aluminum, guarantees their product from chipping, blistering, or peeling while under the conditions of normal use for the period of twenty years from the date of installation as shown on the warranty card and are subject to the following rules and conditions:

Two year full warranty, if the product fails within the first two years under the above conditions, Affordable Aluminum will, upon inspection and validation, replace all applicable parts to the owner within the United States Of America or the customer will be responsible for the increased shipping charges outside the United States at no additional cost to the owner except the applicable labor costs for replacing the parts. After the third year the owner will only be responsible for the labor and Affordable Aluminum will share the cost of materials with the owner on the following pro-rated basis. During the fourth through the sixth year, Affordable Aluminum will be responsible for fifty percent of the cost of the material needed for the repair. During the seventh year, Affordable Aluminum will be responsible for forty percent of the cost of the materials needed for the repair. From the eighth to the twelfth year, Affordable Aluminum will be responsible for thirty percent of the cost of the materials needed for the repair. During the thirteenth year, Affordable Aluminum will be responsible for twenty percent of the cost of the material needed for the repair. From the fourteenth to the twentieth years, Affordable Aluminum will be responsible for ten percent of the cost of the material needed for the repair.

This warrantee is not transferable and only insures the original purchaser. Affordable Aluminum does not insure any component or item installed according to the specification designated (AAMA-1403.3-1891).

This warantee oes not cover fire, hail, ice, wind, acts of god, misuse, abuse, fading, chalking, lightning, erosion of paint, or any other causes beyond control of Affordable Aluminum.

This warrantee must be validated by the owner via filling out the registration card and returning it to Affordable Aluminum within forty days of the original installation; all warrantees are void unless the forty days deadlines are met.

Affordable Aluminum is not responsible for any indirect, special, incidental, punitive, or consequential damages and/or losses the owner may suffer due to or in connection with this product or in its use. This warrantee gives the owner specific rights and the owner may have their rights which vary state by state.
